### **PUBLIC COMMENT:**

Cindy Timmermann - Came to the Council to discuss the Buddy Walk. Learned that she will bring the buddy walk to the park board next week and then bring to the City Council next time.

Tricia Buehne and Stephanie Altizer are concerned with Best One Tire - with all of the traffic, we would like there to be some sort of sidewalk so that kids can have a safe place to walk with all of the additional truck traffic that Best One has brought. Mayor Charlie Hilmes informed them of the Council's decision to install a temporary sidewalk now and then a permanent one after the round-about is complete. Bid opening is January 19th. The state will need to review who the contract winner is. Once the contractor is determined and the location of the temporary road locations have been determined, the temporary sidewalk can then be installed. Mayor Hilmes asked that it be stressed to the neighborhood that extreme caution will need to be taken this next year due to the construction zone, regardless of the sidewalk installation.

In 2017 the City of Breese, in an effort to save some money, partnered with Bill Schmaltz, Principal, Einstein Consulting Group, to create a self-insured model for the City of Breese. Compared to the health insurance budget, the City of Breese saved \$137,000 in the first 12 months of their new cost management program. Bill spoke to those in attendance about the following program improvements for 2018:

- Enrolled employees in Teledoc program to provide 24/7 access to a physician. Total cost for unlimited visits averages \$2.37 per person, per month.
- Improved access to wellness exams now including 3D imaging
- In-house health care assessments available to identify and address health concerns
  - The goal of early assessment is to address medical risk and conditions before they result in later, escalated expenses to the employee and City.

## Mayor's Report

Mayor Hilmes would like to compliment the students, the parents and the fans of both Central and Mater Dei. Both schools came together and wore pink to show support in the fight against cancer. It is a fantastic sight to see them come together in support.

Mayor Hilmes also wanted to make mention of a situation with Waste Management. One resident complained that his trash can was run over by the truck. Waste Management stepped up and gave him two options, that they would give him \$25 for a new can, or would provide him with a new can to use. Mayor Hilmes stated that when a company does the right thing, it should be publicly recognized.

Mayor Charles E. Hilmes called the meeting to order at 7:30 P.M.

## **PUBLIC COMMENT:**

Ben Porush wished the council Happy Holidays and thanked the Mayor and the City for working through this process. Also thanked the members of the community for coming to the town hall meetings and the participation. Stated that their goal is to become part of the community and are grateful for the opportunity. Introduced Randy Porter, David Porush, Meggann Bell and Andrew Carruthers.

Frank Richter asked how the Princeton units compare to the intended units in Breese and wondered why the Breese plans seem to be smaller units than Princeton? Also inquired about the PUD. John Becker explained that commercial and residential can be built in the same plot. This will allow for the civic center to be built within the residential. Frank Richter questioned if 3 Diamond Development would be requesting TIF assistance. Mayor Hilmes stated that they will not be seeking TIF. Frank Richter also inquired about rent charged in Princeton and wondered if Breese rent would be charged at the same rates. Ben Porush explained that the rent is set based on locality and is set by HUD. This is formulated based on area median income. Ben also stated that in regards to the Princeton design - 3 Diamond takes into account the design and architecture of the town in which they are building so that it matches the local design. Frank Richter checked with the county assessor's office and was concerned about how low the property was valued at in Princeton and wondered if that would be the same here. Ben explained that he is not a tax expert but is certain that whatever the county deems to be a fair assessment, they will pay the full amount. The assessors determine that amount, not 3 Diamond. Frank Richter questioned if utilities and drainage have been assessed yet. Public Works Manager/Building Inspector Don Voss explained that the additional load of these units will be minimal. Mayor Hilmes stated that the reason that the 2 additional lift stations that were installed were to help with future drainage issues.

Lori Diesen, lives right across from the property. Is inquiring if anyone has reviewed census data yet, and have we, as the City of Breese, taken into consideration single-family homes that will bring in full tax? I have had many people ask me, "How many empty lots do we have here in Breese?" Lori is concerned that we will not be bringing in younger families without lots to build on. Mayor Hilmes stated that many young couples are moving into town into 'starter homes' and remodeling them. Mayor Hilmes stated that he would love to see a farmer near here sell some farm ground to start a new subdivision. It was explained that the ground that 3 Diamond is planning to buy is zoned commercial and would not be used for a subdivision, either. Lori asked if the City could just re-zone it residential? Mayor Hilmes stated that we are not a dictatorship and cannot direct who land owners can/should sell to. Lori also stated that she has been to each of these meetings and feels like everyone comes out of the meetings with the same questions. Mayor Hilmes asked for an example. Lori stated that she still has not seen the market survey. Shelley Shadegg presented Lori with a copy of the survey. Mayor Hilmes stated that it has been at City Hall and available for review - there have been a number of citizens that have come to City Hall to review.

Cynthia Young inquired again about drainage. Mayor Hilmes explained the difference between permeable and impermeable land and the differences that need to be taken into consideration. Cynthia is concerned about the water that comes down 13th street and drains into the fields. Mayor Hilmes assured Cynthia that the construction plans will over-engineer for the drainage and that the building codes will ensure proper drainage. Public Works Manager/Building Inspector Don Voss explained that the water will continue to drain through the infrastructure of the subdivision and flow away. The drainage will actually be better than it currently is today. Mayor Hilmes invited anyone interested to attend City Council Meetings to review any and all plans for the development prior to approval. Question for the Council, "What will you do if this painted picture cracks and fades?"

Mayor Hilmes stated that, if the developers had chosen to purchase ground in an R1 or R2 zone, they would not have even needed this special use permit. The Mayor and the Council Members have all asked these questions time and time again. The council wanted to make sure that the residents had their concerns addressed and ensured Town Hall meetings were conducted. The Mayor stated that he cannot guarantee that things beyond our control but is confident that the City has held the developers to a high standard. Cynthia stated that she is still concerned that she has not seen any concrete plans. Mayor Hilmes stated that while there are no concrete plans today, they will all have to be approved before there can be building permits issued and that the City will do everything possible to ensure that this is done properly. Cynthia asked how the building permit is issued. Don Voss explained the process and that the plans will go back and forth between civil engineers and the city until code is met. Once code is met, they can obtain permits and begin construction.

Frank Richter asked if there was a list being formulated of interested potential residents. Ben stated that they are keeping an 'interest list' and those individuals will be contacted no more than 90 days before the application can be improved, because the application is only good for 90 days.

Alderman Timmermann stated that when this project began, he was opposed. He has talked to developers, friends, bankers and 3 Diamond Development and stated that he is now in favor of the project, because of the safeguards that have been put in. These safeguards include reserve funds, annual audits, taxes, insurance, inspections, etc. 3 Diamond has provided previous inspections for the Council to review and their track record is good. The City also has a track record of looking out for the community and building solid developments.

Mayor Hilmes thanked the visitors for the civility of the discussion.
